

Agreement - Foreign Workers and Interns

By choosing to come to Université Laval, I certify that:

- I. I have read the procedures on this [webpage for foreign workers and interns coming to Université Laval during the COVID-19 pandemic](#) and am particularly aware that:
 - a) [full vaccination according to Canadian standards](#) is required to enter Canada under a work permit exemption
 - b) as of January 15, 2022, [full vaccination according to Canadian standards](#) will be required to enter Canada with a work permit
 - c) if I am a postdoctoral or medical fellow or a training or research intern and that my fellowship or internship will take place in a health and social services establishment or a research center adjacent to such an establishment that I will need to be [adequately protected against COVID-19](#), that without this protection, I will not be able to register or do my fellowship or internship at Université Laval and that this protection may differ from the [Canadian vaccination standards](#);
- II. I am aware of the [penalties should I not comply with quarantine rules or provide incorrect information on my vaccination status](#);
- III. I assume full responsibility for risks associated with travel to and entry into Canada, particularly those associated with the COVID-19 pandemic;
- IV. I acknowledge that Université Laval is not responsible for Canadian immigration rules and measures, including biometrics, medical examinations and processing times for work permits, visas or electronic travel authorizations, nor is it responsible for decisions by federal authorities regarding applications for permits, visas, electronic travel authorizations or entry into Canada. This includes any impacts the COVID-19 pandemic may have on the availability of and the processing times for such services;
- V. I acknowledge that Université Laval is not responsible for decisions made by airlines (e.g. availability of flights, boarding procedures) or for the decisions of other countries (e.g. border closures or openings);
- VI. I acknowledge that Université Laval is not responsible for the availability of services— or any associated fees—pertaining to Canada's entry rules during the COVID-19 pandemic, such as pre-departure testing, vaccination, proof of vaccination, the ArriveCAN application and arrival testing;
- VII. I understand that travelling to Canada during the COVID-19 pandemic may pose health risks;
- VIII. I undertake to prepare a quarantine plan and, if necessary, to carry out the quarantine;
- IX. I understand that, due to the evolving COVID-19 pandemic, the rules of any Canadian, Quebec or foreign authority may change at any time, particularly with respect to borders, immigration and public health measures. I understand that I must keep informed about the situation and respect any rules that may be implemented;
- X. I will notify Université Laval of my arrival at least one week in advance using this [form](#).
